Week 10: March 18, 2022

Last week was uneventful with most of the Legislative time being spent in caucus discussions and budget talks. There was some floor work done but most of the bills were non-cons, clearing the calendar for the few controversial bills left to debate.

This week is the second funnel deadline for policy bills. This means that Senate bills must be reported out of House Committees and House bills out of Senate committees. As with the first funnel rules, Ways and Means bills as well as Appropriation bills are "funnel proof". A few of our monitored bills died in the funnel this week. Below is a brief description:

- HF-2326, dealing with traffic violations and stationary vehicles died in the House but SF-2133, its companion bill, was placed on unfinished business in the Senate so it survived.
- SF-2141 is a hands-free bill died but the companion bill in the House was referred to Ways and Means so it survived.
- SF-2278, a Civil Service bill, did not survive funnel.
- Both collective bargain bills drafted in the House failed to make it through funnel.

As we've discussed in years past, bills that have died due to funnel can still be revived as an amendment in other policy bills or appropriation bills. This process is rare but will warrant monitoring regardless. The bill watch has been updated with these changes.

A good portion of the budget bills were introduced in the House this week and it's assumed that the rest will run through committee early next week. The Senate hasn't moved a budget bill as of this close of business this week. It is likely they will start moving them next week allowing the full negotiations between the chambers to begin. There has obviously been private discussion with the leadership on the overall budget numbers, but floor debate brings those discussions to the rank and file. These floor debates usually don't bring about major changes although sometimes small changes can bring forward hours of debate. Either way, it looks like the end of session could come within the next 30 days baring any major roadblocks between the chambers.
