A NOTE FROM DIRECTOR CARNEY

First and foremost, our thoughts and support go out to all of our friends at the Waterloo Police Department. We would also like to express our support to all those around lowa dealing with the devastating floods. In the Basic Academy, this abbreviated week of training will close out week 10 for Classes 315 and 316.

Due to a collective effort during the most recent legislative session, we were able to secure additional funding for the ILEA Basic Academy for the first time in several years. County and municipal agencies are now responsible for 1/3 of ILEA Basic Academy tuition while the State covers the remaining cost. As a result, the amount charged to county and municipal agencies has been reduced to \$4,800 per ILEA recruit. Our efforts will continue to further reduce your costs. Recruits were on the move in June with scenarios, scenarios, and more scenarios in SFST, Domestic Violence, ALERT, Medical, and High Risk Stops.










ACCESSING YOUR ORGANIZATIONAL ROSTER

- The transfer of an existing POST score
- The order of an MMPI usage, that is not taken with 30 days of being issued by ILEA
