## DRIVING INSTUCTORS AND IOWA CODE REQUIREMENTS

Our records indicate there are currently 293 ILEA-certified driving instructors across the state. While that number may seem substantial, **seventy-seven of those instructors are employed at four agencies**: the Department of Public Safety (DPS), the Department of Natural Resources (DNR), the Des Moines Police Department, and the Cedar Rapids Police Department.

Additionally, **thirty-nine counties do not have** a driving instructor within either their respective Sheriff's Offices or municipal departments. Many counties only have one driving instructor who is attempting to train several agencies.

This shortage presents a significant challenge as driver training is now required for both reserve and full-time police officers to obtain qualified immunity under lowa Code section 321.231B(1)(c). This training consists of a classroom component and six hands-on driving courses, all of which must be conducted by an ILEA-certified driving instructor.

Currently, three Precision Driving Instructor Courses are scheduled for 2026. These courses tend to fill quickly, so priority enrollment will be given to agencies that do not currently have a certified driving instructor.

#### **IADLEST MIDWEST REGION MEETING**

The ILEA recently hosted the International Association of Directors of Law Enforcement Standards and Training (IADLEST) Midwest region meeting. The meeting was attended by POST directors, academy directors and academy staff from Iowa, Kansas, Nebraska, North Dakota, Texas, Wyoming and the IADLEST Executive Board. Conversations centered on growing use of the National Decertification Index (NDI), ensuring high minimum standards, the need for evolving basic academy instruction and curriculum, the need for standardized basic training requirements that result in statewide licensure/certification and adequate staffing and facilities to successfully carry out all POST and academy functions. #### **IN-SERVICE REQUIREMENTS FOR LEO'S**

Please remember that pursuant to HF856, the Implicit Bias is no longer an in-service requirement even though it remains listed in the administrative rules. This will be addressed in the impending rules rewrite.

## CHAPTER 8 MANDATORY IN-SERVICE AND SPECIALTY TRAINING REQUIREMENTS

501—8.1(80B) Mandatory in-service training requirements. All regular law enforcement officers shall meet the following in-service training requirements. The elected or appointed official designated as the head of the agency employing the regular law enforcement officer shall ensure compliance with the training requirements listed.

**8.1(1)** Mandatory training and certification requirements. A regular law enforcement officer must receive in-service training from a course of study approved by the Iowa law enforcement academy.

- a. Annual firearms qualification
- b. National crime information center (NCIC) certification (Federal Bureau of Investigation)
- c. Hazard communications (OSHA Standard 1910.1200(h))
- d. Hazardous materials (OSHA Standard 1910.120(q)(8)(i))
- e. Bloodborne pathogens (OSHA Standard 1910.1030(g)(2))
- f. Implicit bias/de-escalation training (Iowa Code section 80B.11G)
- g. Mental health training (Iowa Code section 80B.11(1) "c"(3))
- h. Cardiopulmonary resuscitation (CPR), AED and foreign body airway obstruction for all age groups. (Standards defined by the International Liaison Committee on Resuscitation)
- i. Mandatory reporter training for child and dependent adult abuse provided by the department of human services (Iowa Code sections 232.69(1)"b"(11), 232.69(3)"b," 235B.3(2)"b" and 235B.16(5)"b"). A child abuse or dependent adult abuse training certificate relating to the identification and reporting of child abuse or dependent adult abuse issued prior to July 1, 2019, remains effective and continues in effect as issued for the five-year period following its issuance.
- **8.1(2)** General training. In addition to the requirements of subrule 8.1(1), a regular law enforcement officer must receive a minimum of 12 hours per year of law enforcement-related in-service training. Whether training is law enforcement-related shall be determined by the employing agency administrator. [ARC 6264C, IAB 3/23/22, effective 4/27/22]
