LEO'S MOVING FROM AGENCY TO AGENCY

We continue to review past practices and examine how they align with existing Administrative Rules and Iowa Code. Alignment in these areas is essential, so we will continue to make progress.

For Law Enforcement Officers:

- If a break from law enforcement service is 180 days or less, ILEA only needs a Report of Hire to document employment at a new agency.
- If a break from law enforcement service is more than 180 days, the individual will need a suitable psychological evaluation and be of good moral character as determined by a thorough background check including fingerprints. (501-2.3(80B))

For Reserves:

- If a break from law enforcement service is 180 days or less, ILEA needs a Report of Hire and an updated weapons application for the new agency/department/office. (501-10.6(80D))
- If a break from law enforcement service is more than 180 days, the individual also needs to be of good moral character as determined by a thorough background check including fingerprints. (501-10.8(80D))



Implicit Bias In-Service Training Requirement Pursuant to HF 856:

Based on guidance from the Iowa Attorney General's Office, Implicit Bias is no longer an annual in-service requirement for law enforcement officers or reserve officers. However, four (4) hours of de-escalation training are still required for law enforcement officers and reserve officers.

The ILEA has fielded questions regarding the appropriate physical testing standards for **transgender applicants**.

The Iowa Attorney General's Office has provided the following guidance: Following Iowa law that allows for sex designations to be legally changed on birth certificates, the sex designation on the individual's birth certificate at the time of physical testing determines the applicable sex-based standards.

NATIONAL DECERTIFICATION INDEX


